What is the overall <a href="#">deductible</a> ?	\$500 individual / \$1,000 family	You must pay all the costs up to the <a href="#">deductible</a> amount before the policy begins to pay for covered services you use, with the exceptions of office visit <a href="#">copays</a> and for federally required preventive services. The deductible starts over with each plan year beginning on January 1 <sup>st</sup> . See the chart starting on page 2 for your costs for services this plan covers.
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive care</a> and primary care services are covered before you meet your <a href="#">deductible</a> .	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. For example, this <a href="#">plan</a> covers certain <a href="#">preventive services</a> without <a href="#">cost-sharing</a> and before you meet your <a href="#">deductible</a> . What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	Durable Medical Supplies (DME): \$500 per individual. Prescription drug: Level 1 and 2: \$600 individual / \$1,200 family Level 4: \$1,200 individual / \$2,400 family	The <a href="#">out-of-pocket limit</a> is the most you could pay during a coverage period (usually one year) for your share of the cost of covered services. This limit helps you plan for health care expenses. The federal <a href="#">maximum out-of-pocket</a> is \$6,850 individual/\$13,700 family. This applies to all essential health benefits, including some services not included in the <a href="#">out-of-pocket limit</a> . (i.e. certain level 3 & 4 prescription drugs and certain hearing aids covered under this plan). What is not included in the <a href="#">out-of-pocket limit</a> ?	<a href="#">Copays</a> for Level 3 and Level 4 non-preferred <a href="#">specialty</a> drugs; <a href="#">coinsurance</a> paid by adults for hearing aids, <a href="#">premiums</a> and health care this plan doesn't cover.
